1. CALL TO ORDER

The meeting of the Western Riverside County Regional Conservation Authority Executive Committee was called to order by Chairman Gary Thomasian at 12:05 p.m. in the RCA Conference Room, 3403 Tenth Street, Suite 320, Riverside, California.

5. ADDITIONS/REVISIONS

Steve DeBaun, Legal Counsel, requested that the Executive Committee add a late breaking item to Closed Session. 7. FISCAL YEAR 2009-10 SECOND QUARTER FINANCIAL REPORT AND BUDGET ADJUSTMENTS

Honey Bernas, Director of Administrative Services, presented a summary of the second quarter financial report. The revenues, appropriations and cash balance as of December 31, 2009 were as follows:

Honey Bernas further advised that budget adjustments were necessary as follows. In Department 935100, it is necessary to increase revenue by \$499,349 and increase appropriations by \$835. In Department 935201, it is necessary to decrease revenue by \$2,812,663 and decrease appropriations by \$1,042,454.

8. EXECUTIVE DIRECTOR'S REPORT

Charlie Landry, Executive Director, reported on the following items:

8.1 RCA Newsletter

The newsletter provides information on the RCA, how the Multiple Species Habitat Conservation Plan (MSHCP) works, the cities and County's obligation, accomplishments to date, and the affect on the economy to the MSHCP. Input from Board Members on the newsletter is appreciated.

Chairman Thomasian said that the information in the newsletter offers assistance to cities, county, and the public in the process and determining if a property is within a criteria or linkage area, as well as resource information.

Melissa Melendez asked if the public was informed on Plan Areas and conservation prior to implementation of the MSHCP. Eugene Montanez said that stakeholders, which included property owners, were involved and members of a committee. Michelle Ouellette added that notifications were sent to property owners and public hearings were held in various areas.

8.2 Report on Consultant Services – Thomas B. Mullen

From July 2, 2009 through December 31, 2009, Tom Mullen has been working with the offices of Senators Dianne Feinstein and Barbara Boxer and coordinating with the California Habitat Conservation Plan Coalition to overturn the policy change made by the U.S. Fish and Wildlife disallowing use of local development mitigation funds as match for Section 6 funding. In addition, he continued to work on an initiative for developing additional funding and programs to support MSHCP agencies in consult with Senator Feinstein, the Coalition, state and federal agencies, and Congressmen Ken Calvert and Jerry Lewis. He was involved in the preparation of the Summit on Infrastructure and the Environment which served to recognize MSHCPs and provided a structure for an additional funding mechanism for the Plan. Review of activities in Washington, D.C., followed.

8.3 RCA Board Workshop

A workshop for RCA Board Members is being planned for Monday April 12, 2010, from 9:00 a.m. to 12:00 p.m., at the County Administrative Center, Conference Rooms 2A and 2B. Subject areas to be covered include RCA goals and objectives, status of the MSHCP, acquisitions, rough step, obligations for public projects and collection issues, etc. Staff will send an email to check Board Members' availability and to request that they save the date and time for the workshop.
