7. APPROVAL OF MINUTES

8. FISCAL YEAR 2014 FOURTH QUARTER AND FISCAL YEAR 2015 FIRST QUARTER CONSULTANT REPORTS FOR DOUGLAS P. WHEELER, HOGAN LOVELLS US LLP, AND DAVID KENNETT, CAPITAL ALLIANCE CONSULTING.

Maryann Edwards entered the meeting during the presentation.

David Kennett of Capital Alliance Consulting and, through Skype, Douglas Wheeler of Hogan Lovells US LLP presented an update on the following subject items: 1) Federal funding for habitat acquisition; 2) Critical habitat designations on MSHCP land; and, 3) Loan/loan guarantee legislation. As of this date, the FY 2015 Section 6 funding is yet to be determined. The House proposed \$49.2 million and the Senate proposed \$40 million (this amount includes a \$10 million reduction for habitat acquisition). Appropriations of \$50 million and \$50 million automatic funding for Section 6 are included in the President's budget request.

Senator Dianne Feinstein and Congressman Ken Calvert continue to support RCA's proposal for a loan program. In consultation with the House and Senate membership, the Administration and Stakeholders, Senate Bill 1175 (Feinstein) and HR 2280 (Calvert) were introduced. This proposed legislation will provide for a pilot program of loans and loan guarantees to be administered jointly by the Secretaries of the Treasury and Interior. The version of the bill was included in the Water Resources Development Act (WRDA). They added that Senator Barbara Boxer, under her proposed legislation, included language allowing TIFIA loans to be used to buy land for HCPs that foster transportation projects.

However, the House has not yet passed a version of the bill. This will be taken up in the next Congress.

11.2 Section 6 Update

Charlie Landry gave an update on Section 6 funding. For the years 2012, 2013 and 2014 the RCA has been given a total of \$8.27 million in Section 6 grants. When the State match is included, the total is approximately \$11 million. To date, RCA has spent \$5.6 million. Staff has identified qualified properties to expend the rest of the funding. The properties are either in the appraisal phase or the appraisals are being reviewed by the Department of General Services. The grant funding needs to be expended in order to receive additional funds.

11.3 Report Back Concerning RCA Investments

Charlie Landry gave an overview of the RCA Investment Policy, which Jeff Stone suggested staff review to determine if there were investment options available that would provide a higher yield. Staff met with Don Kent, Riverside County Treasurer, Jon Christensen, and staff to discuss RCA investment options. There are higher yield investment options available to RCA; however, those options require longer-term investments. Because of the timeline set forth in the MSHCP to purchase properties, acquisitions in process and current funding, it was determined that long-term investments may not be in the best interest of the RCA at this time. Long-term investments could result in RCA losing dollars if the money was needed early. However, if there is an upturn in development fees and the loan program is approved and in place, staff will revisit RCA's investment options.

12. LAND ACQUISITION UPDATE

Charlie Landry reported that since the last meeting, the RCA has conserved an additional fifteen (15) acres, bringing the reserve total to 48,268 acres.

13. ITEMS FOR NEXT MEETING

Thomas Fuhrman informed the RCA Board of the latest cougar strike that killed a horse and two alpacas. He cautioned that the next victim may be a human or a child, unless the problem is taken care of.

There were no items requested for the next RCA Board meeting.
