

**RESOLUTION NO. 2011-47**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JURUPA VALLEY, CALIFORNIA APPROVING MEMBERSHIP IN THE WESTERN RIVERSIDE COUNTY REGIONAL CONSERVATION AUTHORITY**

**WHEREAS**, the City of Jurupa Valley was incorporated on July 1, 2011, as a General Law City of the State of California; and

**WHEREAS**, the City is eligible to participate in various organizations representing the interests of the City; and

**WHEREAS**, the Western Riverside County Regional Conservation Authority (RCA) is a public agency of the State of California formed by a Joint Exercise of Powers Agreement responsible for administering the Western Riverside County Multiple Species Habitat Conservation Plan; and

**WHEREAS**, the RCA is comprised of the County of Riverside and seventeen (17) western Riverside County cities, and the City will benefit from membership in such organization.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF JURUPA VALLEY RESOLVES AS FOLLOWS:**

**Section 1.** The above recitals are incorporated herein by this reference;


**Section 2.** The City Manager is authorized to and shall take the necessary steps for the City to join the RCA, and the Mayor is hereby authorized to enter into the JPA for the RCA on behalf of the City, and to execute other documents necessary for the City to join the RCA.

**Section 3.** The City Clerk shall certify as to the adoption of this Resolution.


